

**RFB 5816 Authorization to Issue a Blanket Purchase Order to Goldfish Inc for Uniforms**

The Administration is requesting authorization to enter into a blanket purchase order to Goldfish Inc for uniforms. This vendor will be used to deliver uniforms and apparel to the Department of Facilities and Maintenance Services (DFMS).

Contractor was chosen pursuant to RFB 5816, which closed on December 22, 2023. The contract for the winning bidder for this solicitation was not renewed for years two and three due to performance deficiencies. Goldfish Inc satisfied all solicitation requirements and was the second-place bidder.

The blanket purchase order will run from April 1, 2025 through March 31, 2027, and will not exceed \$300,000.

Through individualized learning paths, the platform assesses students’ knowledge, addresses gaps in academic standards, and facilitates efficient credit recovery.

This tool serves as the primary platform for MPS high schools to provide self-paced credit recovery, supporting up to 2,500 students during the school year and 5,000 during Summer Academy. This agreement will provide access to Imagine Learning and Imagine Edge EX suite of courses, which align with MPS course standards.

The platform is intended to serve a diverse range of students, including students with varied language and academic needs. Key features include real-time, on-demand tutoring across various subjects, allowing students to receive tailored assistance whenever needed. This flexible support helps students stay on track to meet their academic goals. Additionally, the subscription includes professional development webinars, which equip educators with effective strategies for seamlessly integrating the platform’s tools into the classroom and ensuring the program’s success.

The purchase will be made under The Interlocal Purchasing System (TIPS) Contract #230105, and the subscription term will span three years, from July 1, 2025, to June 30, 2028. The total cost will not exceed \$1,123,500.00 or \$374,500.00 annually.
