**MILWAUKEE BOARD OF SCHOOL DIRECTORS  
PROFESSIONAL SERVICES CONTRACT  
FINAL EXTENSION & MODIFICATION**

On April 1, 2020, the Milwaukee Board of School Directors and Baker Tilly Virchow Krause, LLP entered into Professional Services Contract number C029472 (“Contract”), with a term of July 1, 2020 through June 30, 2023. Baker Tilly Virchow Krause, LLP is now known as Baker Tilly US, LLP. The Contract, Section 2, provided for two additional one-year extensions upon mutual written consent of the parties and was previously extended for the first one-year term (the “First Extension”). The parties now mutually agree to extend the Contract for the final one-year term.

As such, the Contract will be extended for the final one-year term, from December 1, 2024 through June 30, 2025 (“Year 5”), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

**MODIFIED TERMS:**

1. Section 1, SCOPE OF SERVICES, of the Contract is modified to include the following provision: “Contractor shall perform the FY24 Financial Statement Audit and the FY25 membership/parental consent/integration transfer AUP. Contractor shall provide MPS with eight (8) hours of free training to be scheduled through the CFO Office. Contractor shall ensure adequate qualified coverage when primary staff is out of office or unable to perform work due to any absence. In the event a senior level staff member must complete work typically done/assigned by a subordinate due to any absence or staff reassignment, Contractor shall charge at the rate of the subordinate. Contractor shall review and respond to submitted documents within ten (10) business days of receipt.”
2. Section 2, TERM, of the Contract is modified to include the following provision: “This Contract shall be in effect from December 1, 2024 through June 30, 2025 (Year 5).”
3. Section 3, COMPENSATION, of the Contract, is modified to include the following provision: Total compensation under this Contract shall not exceed \$333,710 for the period December 1, 2024 through June 30, 2025 (“Year 5”).
