ADMINISTRATION'S RECOMMENDATION

The Administration recommends that the Board approve the following contracts:

RFP 1036 Authorization to Modify Compensation on the Current Agreement with School Bus RFP 1050 Contractors for Yellow Bus Transportation Services for Students

The Administration requests authorization to modify the compensation agreement for current school bus contractors that service MPS as part of a strategy aimed at improving student transportation services for fiscal year 2022 (FY22).

Since the start of FY22, a significant inflation rate increase and the ongoing nature of the COVID-19 pandemic continues to exacerbate the bus driver shortage. School Transportation News estimates that 80% of school districts and bus companies are experiencing a driver shortage. The increased cost on bussing companies threatens unsustainable operational losses that contractors cannot absorb without addressing through a collaborative approach.

As such, the Administration is now requesting a modification to provide a \$30 Operations Surcharge per bus route per month that assists bus companies in meeting or exceeding their bus quota driven exclusively for servicing MPS.

The addendum is for a term of July 1, 2021 – June 30, 2022 and would not exceed \$3,283,000.
