**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT
FIRST EXTENSION**

On July 1, 2022, the Milwaukee Board of School Directors and City Year, Inc. entered into Professional Services Contract number C030701 (“Contract”), with a term of July 1, 2022 through June 30, 2023. The Contract, Section 2, provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor’s achievement of those performance metrics, the parties now mutually agree to extend the Contract for the first and second one-year terms.

As such, the Contract will be extended for the first and second additional one-year terms, from July 1, 2023 through June 30, 2025 (Years 2 and 3), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 1, Scope of Services, of the Contract is modified to include the following additional language: “Contractor shall ensure a minimum of ten (10) AmeriCorps members (staff) on site at each school served at all times.”
2. Section 2, Term, of the Contract is modified to include the following additional language: “This Contract is extended for an additional two years (Years 2 and 3), with a term of July 1, 2023 through June 30, 2025.”
3. Section 3, Compensation, of the Contract is modified to include the following language: “Total compensation under this Contract for Years 2 and 3 shall not exceed \$3,710,000.00. Invoices shall provide detail including dates/times and names of staff for each school supported, demonstrating a minimum of 10 staff for each school at all times services are provided. Compensation will be prorated for fewer than 10 staff documented per school.”
