#### **NEW BUSINESS**

#### **OUALITY IMPROVEMENT FUNDING APPLICATION**

Raquel de la Cruz Gutiérrez, Education Coordinator, and Dr. Kerrie McCullough, ERSEA/FPA Coordinator, shared information regarding the Quality Improvement Funding Application. The three main requests in this application are: 1) to increase the number of Family Partnership Associates (FPAs), 2) extra hours for Head Start staff, and 3) the use of consultants for improving trauma-informed practices and social-emotional learning.

Albert Robbins, Policy Council Advisor, asked for an example of what trauma-informed care looks like. Raquel de la Cruz Gutiérrez, Education Coordinator, responded with an explanation of trauma-informed care and the training needed in MPS Head Start classrooms to deal with situations such as violence, eviction, etc. Erin Hermann, Education Coordinator, gave a few examples of interventions such as light covers, fidgets, and calming areas. She indicated that each child and situation are unique with different needs.

Eunice Heredia, Lincoln Avenue, motioned to approve the funding application. Latrisha Grayson, Obama, seconded the motion. The motion passed unanimously.

# COST-OF-LIVING ADJUSTMENTS (COLA) FUNDING APPLICATION

Julie Schlipmann, Education Coordinator, and Natalie Philippe, Mental Health and Disabilities Coordinator, shared information regarding the COLA Funding Application. As Head Start staff has received cost-of-living raises in excess of 2%, the funding will be used to cover increased operating costs at Grant Gordon Learning Center. No questions were asked.

Eunice Heredia, Lincoln Avenue, motioned to approve the funding application. Latrisha Grayson, Obama, seconded the motion. The motion passed unanimously.

# CARES (CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY) FUNDING APPLICATION

This is a one-time funding application to provide face-to-face learning for K4 students and K3 students with special needs to make up for missed classroom time due to the COVID-19 pandemic. No questions were asked.

Eunice Heredia, Lincoln Avenue, motioned to approve the funding application. Latrisha Grayson, Obama, seconded the motion. The motion passed unanimously.

## SIMPLIFICATION FOR CONSOLIDATING HEAD START GRANTS APPLICATION

Joandy Williams, Early Childhood Learning Manager, and Erin Hermann, Education Coordinator, shared information regarding the Simplification for Consolidating Head Start Grants Application. Albert Robbins, Policy Council Advisor, asked if the consolidation would be completed by the federal government. Erin Hermann, education coordinator, responded, that yes, both grants are federally funded and would be consolidated at the federal level if approved.

Eunice Heredia, Lincoln Avenue, motioned to approve the funding application. Latrisha Grayson, Obama, seconded the motion. The motion passed unanimously.
