The contract extension will run from August 1, 2017 through June 30, 2018. The total cost of the contract extension in this extension term will not exceed \$544,500.

#### RFP 878 Authorization to Extend Contracts with EBS Healthcare, Inc., and Rehab Solutions, LLC, and Enter into a Contract with MJ Care, Inc. for Speech-Language Pathology Services

The Administration is requesting authorization to extend the contracts with EBS Healthcare, Inc. ("EBS") and Rehab Solutions, LLC ("RS") and enter into a contract with MJ Care, Inc. ("MJ") for speech-language pathology services. These contracted services are necessitated by the severe shortage of speech-language pathologists that MPS is facing, rendering MPS unable to fill its vacant speech-language pathologist positions. These contractors provide speech-language services as required by Individual Education Plans when staff vacancies exist for short- and long-term employee leave.

EBS and RS were both chosen pursuant to RFP 878. The original contracts provided for two one-year options to extend if certain performance metrics were met. Both vendors met the performance metrics codified in the contracts; therefore, MPS is exercising the second option year for both these contracts. MJ was not initially chosen as an awardee, but when contracts from RFP 878 were first awarded, a third vendor, Lingua Health, LLC ("Lingua") was awarded a contract. Lingua was not utilized during the course of the first year of the contract and no contract extension was exercised. The Administration looked first to Lingua and requested to recommence its contract for FY18, but was advised Lingua cannot fill the vacant speech-language pathologist positions. Since MJ was the fourth-highest-ranked vendor in the RFP, the Administration has offered a contract to MJ. MJ has stated it is able to fill the vacant positions.

The contract extensions with EBS and RS, and the contract with MJ, will run from July 1, 2017 through June 30, 2018. No funds are being requested to be added to the extensions with EBS and RS as there are sufficient funds remaining on the contracts for this extension term. The total cost of the MJ contract will not exceed \$93,080.

The Administration is requesting authorization to extend two contracts with Sunbelt Staffing Solutions, Inc. (Sunbelt), for registered nurse (RN) and licensed practical nurse

(LPN) services. This contractor provides RNs and LPNs, as needed, to schools across the District.

Direct nursing care services are critical to maintaining the health and wellness of MPS students. RNs work directly with the student population to address a variety of health-related issues. Certified LPNs are assigned, as needed, to work one-on-one with medically fragile students that are using ventilators.

Sunbelt was chosen pursuant to RFP 880. Two separate contracts, for RN services and LPN services, were executed. The original contracts provided for two one-year options to extend if certain performance metrics were met. Sunbelt met the performance metrics codified in each contract; therefore, MPS is exercising the first option year for the contracts.

The contract extensions will each run from September 1, 2017 through August 31, 2017. The total cost of the RN contract in this extension term will not exceed \$522,828. The total cost of the LPN contract in this third extension term will not exceed \$361,584.

## RFP 935 Authorization to Enter into Contracts with Catapult Learning West, LLC and Owners Group d/b/a Learning Exchange for Title IA, IIA and IIA Services

The Administration is requesting authorization to enter into contracts with Catapult Learning West, LLC and Owners Group d/b/a Learning Exchange for Title IA, Title IIA, and Title IIIA services. Title IA educational services are provided to eligible City of Milwaukee students attending non-public schools. Title IIA professional development services are provided to non-public school personnel. Title IIIA services are provided to eligible City of eligible City of Milwaukee English Language Learners attending non-public schools.

MPS is required by federal legislation to provide these services. Services include supplemental instruction for students at risk of failing and/or who are English learners, professional development for educational staff and parental involvement activities.

These contractors were chosen pursuant to RFP 935, which closed on January 19, 2017. The contracts will run from July 1, 2017 through June 30, 2018 (the "Initial Term"), with two additional one-year options to extend if certain performance metrics incorporated into the contract are met.

#### TCPN Authorization to Increase Funds for the Agreement with Lakeshore Equipment Company for Classroom Furniture and Materials

The Administration is requesting authorization to increase funds on its blanket agreement with Lakeshore Equipment Company d/b/a Lakeshore Learning Materials ("Lakeshore") to make purchases of classroom furniture and materials to support Head Start classrooms and the Achievement Gap Reduction (AGR) program.

In May 2016, the Board approved \$1,280,000 for the initial purchases under the agreement, a piggyback on The Cooperative Purchasing Network's Contract Number R141604. The Administration indicated it would return to the Board if additional funds were needed for future purchases. In July 2016, additional funds in the amount of \$488,687.70 were authorized to refresh additional classrooms. This proposed increase will allow MPS to continue to outfit classrooms participating in Head Start and the AGR program with furniture and materials that are developmentally appropriate for the identified grades levels. Classroom furniture and materials have been selected based upon students' academic and social emotional learning needs and are conducive to instructional practices that encourage growth in both areas.

The estimated cost of materials and services to be purchased under the agreement at this time will not exceed \$1,000,000. If additional purchases are contemplated during the remaining term of the blanket agreement (May 27, 2016 through January 31, 2018), the Administration will again return to the Board for authorization.
