FIRST EXTENSION & MODIFICATION**

On October 1, 2021, the Milwaukee Board of School Directors and Running Rebels Community Organization entered into Professional Services Contract number C030197 ("Contract"), with a term of October 1, 2021 through September 30, 2022. The Contract, Section 2, provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

**MODIFIED TERMS:**

1. Section 1 of the Contract, Scope of Services, is modified to include:
  - Vendor shall provide extended hours of after-school engagement.
  - Vendor shall promote MPS summer resources (Milwaukee Rec, Twilight, Midnight Leagues, Summer Academy) and community resources to youth, families, and partners.
  - Vendor shall teach workforce development skills and connect youth to jobs.
  - Vendor shall teach positive coping skills based on dialectical behavior therapy and juvenile cognitive intervention programming.
2. Section 2 of the Contract, Term, is modified as follows: "The Contract shall be in effect from October 1, 2022 through September 30, 2023."
3. Section 3 of the Contract is modified as follows: "Total compensation under this Contract shall not exceed \$1,442,000.00."
