PERIOD OF CONTRACT: 8/1/2022 through 7/31/2023

This contract is entered into by and between the Milwaukee Board of School Directors (“MPS”) and Edgenuity Inc. (“Contractor”).

Whereby, MPS agrees to direct the purchase and Contractor agrees to supply such requirements of the commodity or service cited above in accordance with the TIPS #200105. This Contract is subject to any amendments to that Contract executed in the future.

Regardless of the pricing contained in Contract TIPS #200105, MPS and Contractor agree to the pricing attached hereto in Quote Documents dated 8/1/2022 and not to exceed \$3,750,000.00 and incorporated by reference.

Contractor acknowledges and agrees that the relationship with MPS is non-exclusive and MPS may contract with as many additional entities as MPS, in MPS’s sole discretion, sees fit.

In accordance with MPS Administrative Policy 3.10, which is hereby incorporated by reference, the following requirements have been assigned to this Agreement: the student engagement requirement of Paid Student Employment for this Contract is 900 hours per 12-month term; and the Student Career Awareness Commitment requirement for this Contract is 20 hours per 12-month term. Failure to achieve these requirements may result in the application of some or all of the sanctions set forth in Policy 3.10.

This Contract, along with Contract TIPS #200105, constitutes the entire agreement between the parties relating to the subject matter of this contract. All prior understandings, agreements, correspondence and discussions of the parties are merged into and made a part of this Contract.

No amendment or modification of any provision of this Contract shall be effective unless the same shall be in writing and signed by authorized signatories of both parties.


