PROFESSIONAL SERVICES CONTRACT
FIRST EXTENSION**

On July 1, 2021, the Milwaukee Board of School Directors and Lamers Bus Lines, Inc. entered into Professional Services Contract number C029882 ("Contract"), with a term of July 1, 2021 through June 30, 2022. The Contract, Section 2, provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor's achievement of those performance metrics, the parties now mutually agree to extend the Contract for the first one-year term.

As such, the Contract will be extended for the first additional one-year term, from July 1, 2022 through June 30, 2023 ("Year 2"), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 3 of the Contract is modified to include the following provision: "Total compensation under this Contract for the period from July 1, 2022 through June 30, 2023 ("Year 2"), shall not exceed \$9,665,548.20."
2. Addendum 1 – Operations Surcharge is modified as follows: "Total compensation under this Addendum will not exceed \$735,000."
