**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT
SECOND EXTENSION & MODIFICATION**

On May 1, 2020, the Milwaukee Board of School Directors and EverDriven Technologies, LLC formerly known as (f.k.a.) ALC Schools LLC (“Contractor”) entered into a Professional Services Blanket Contract number B0001430 (“Contract”) with a term of July 1, 2020 through June 30, 2021. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. The Contract was previously extended for the first one-year term (“Year 2”) from July 1, 2021 through June 30, 2022. The parties now mutually agree to extend the Contract for the second and final one-year term (“Year 3”).

As such, the Contract will be extended for the second and final term (“Year 3”), from August 1, 2022 through June 30, 2023, under the same terms and conditions as set forth in the Contract, except as specifically set forth below.

In accordance with ¶ 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. ALC Schools LLC changed their name and is now known as EverDriven Technologies LLC.
2. Paragraph 2 is modified as follows: This contract shall be in effect from August 1, 2022 through June 30, 2023.
3. Paragraph 3 is modified as follows: “Total compensation under this Contract shall not exceed \$300,000.00.”
4. Paragraph 3 is modified to include the following “Live Mile Rate”:

Component	Live Mile Rate
Ambulatory	\$6.50

5. Paragraph 3 is modified to include the following: There is a 10-mile minimum billing requirement for every trip billed. After the first 10 live miles of a trip, the live mile price will be discounted by \$4.00 per mile reducing the live mile price to \$2.50 per mile for the remainder of the trip.
