

**THIRD AMENDMENT TO LEASE  
BETWEEN  
THE MILWAUKEE BOARD OF SCHOOL DIRECTORS  
AND  
CARMEN HIGH SCHOOL OF SCIENCE AND TECHNOLOGY  
AT  
THE WALKER MULTIPLEX**

**THIS THIRD AMENDMENT TO LEASE** (“Third Amendment”) is made as of the \_\_\_ day of \_\_\_\_\_, 2021, by and between **THE MILWAUKEE BOARD OF SCHOOL DIRECTORS** (hereinafter “the Board”) and **CARMEN HIGH SCHOOL OF SCIENCE AND TECHNOLOGY** (hereinafter “Lessee”).

**RECITALS**

**WHEREAS**, the Board and Lessee entered into that certain Lease dated June 28, 2012; and

**WHEREAS**, the Board and Lessee entered into that certain First Amendment to Lease dated June 29, 2017; and

**WHEREAS**, the Board and Lessee entered into that certain Second Amendment to Lease dated January 24, 2019; and

**WHEREAS**, the Board and Lessee wish to amend the Lease as set forth below.

**NOW, THEREFORE**, the parties hereto agree as follows (all capitalized terms used but not defined herein shall have the meaning set forth in the Lease):

1. Section 2 of the Lease is hereby deleted and replaced with the following:

2. TERM: The term shall commence on July 1, 2021 and will terminate on June 30, 2026, except either party may terminate the lease by providing the other party 60 day written notice of termination. No notice of termination may be given more than 60 days prior to the end of the academic year. Upon termination, Lessee shall vacate the premises in a manner consistent with the terms and conditions of the Lease.

2. Section 3 of the Lease is hereby deleted and replaced with the following:

3. EXTENSION OF LEASE: The term of this Lease may not be extended beyond June 30, 2026.

3. Section 6.a is hereby deleted and replaced with the following:

- a. 2021-2022: \$255,190. 2022-2023: \$260,294. 2023-2024: \$265,500.  
2024-2025: \$270,810. 2025-2026: \$276,226. Rent shall be payable in  
twelve (12) equal monthly payments.
4. Except as modified by this Third Amendment, the Lease shall continue in  
full force and effect as provided therein.
