FIRST MODIFICATION**

On July 1, 2023, the Milwaukee Board of School Directors and Lakeside Ventures, Inc. d/b/a International Languages entered into Professional Services Contract number B0001546 (“Contract”), with a term of July 1, 2023 through June 30, 2024. The Contract, provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 3, Compensation is modified, adding the additional service:
 - A. All language interpretations shall have a minimum billed duration of two hours.
 - B. Cancellation terms: Cancellations must be made at least 24 business hours in advance. Late cancellations will incur charges for the greater between the minimum duration and the initially requested time.
 - C. Billing increments: Subsequent to the initial two hours, services rendered will be billed in thirty-minute intervals.
 - D. ASL assignments will be billed for a minimum of three hours, and in increments of 1 hour thereafter.
 - E. Voice recordings will be billed at \$50.00 per hour.




