SUBJECT: Estimated Effect of Increasing Special Education Proration Rate to 90% or 100%

At your request, I am providing information on the fiscal effects of increasing the special education proration rate to 90% or 100%.

The special education program reimburses school districts and other educational agencies for a portion of the costs for educating and transporting pupils enrolled in special education. Reimbursements are calculated based on eligible costs incurred in the prior year. The proration rate in each year is determined by dividing the amount of available funding by total eligible costs. In 2023-24, funding is equal to \$558,036,700 GPR and in 2024-25, funding is equal to \$574,777,700 GPR. The estimated proration rate in each year is 33.3%.

You asked for information on the estimated effects of increasing the special education proration rate to 90% or 100%, including the amount each district would receive. Attachment 1 shows the preliminary amount of special education aid each district will receive in 2023-24 under current law and the estimated amounts each district would have received in that year if payments were prorated at 90%. Full funding of this proposal would have cost an additional \$969.6 million GPR in 2023-24 above the amount appropriated under current law. Attachment 2 shows the preliminary amount of special education aid each district will receive in 2023-24 under current law and the estimated amounts each district would have received in that year if payments were not prorated and instead districts received payments equal to 100% of their aidable costs. Full funding of this proposal would have increased special education costs by \$1,135.4 million GPR in 2023-24.

The amount each district would actually receive in future years depends on the individual district's special education costs in the prior year relative to the total statewide special education costs; therefore, the actual amounts each district would receive could vary. The attachment only includes public school districts and does not include other entities eligible for special education aid, such as independent charter schools.
