

**FIRST AMENDMENT TO NON-INSTRUMENTALITY CHARTER SCHOOL  
CONTRACT**

**THIS FIRST AMENDMENT TO NON-INSTRUMENTALITY CHARTER CONTRACT** (the “First Amendment”) is made and entered into as of this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_ (“Effective Date”), by and between the Milwaukee Board of School Directors (the “Board”), 5225 West Vliet Street, P.O. Box 2181, Milwaukee, Wisconsin, 53201-2181, and M.C. Preparatory School of Wisconsin, Inc., a Wisconsin not-for-profit corporation (“Charter School Operator”), located at 1228 W. Lloyd Street, Milwaukee, WI 53205. Board and Charter School Operator are each a “Party”; together, they are the “Parties.”

**RECITALS:**

**WHEREAS**, Board and Charter School Operator entered into that certain Non-Instrumentality Charter School Contract Between the Milwaukee Board of School Directors and M.C. Preparatory School of Wisconsin, Inc. for four charter school locations effective as of July 29, 2021, and with a term commencing with the 2021-2022 school year (the “Agreement”); and

**WHEREAS**, the Board and Charter School Operator now desire to amend the Agreement as hereinafter more specifically set forth.

**NOW, THEREFORE**, in consideration of the agreements hereinafter set forth and other good and valuable consideration, the receipt of which are hereby acknowledged, the Parties agree as follows:

1. The foregoing recitals are incorporated herein by this reference.
2. Capitalized terms used and not otherwise defined herein shall have the same meaning as provided in the Agreement.
3. Section III(B) of the Agreement is hereby amended to the following pupil seats total: a maximum of 2,072 FTE pupils in grades K4-8.
4. Except as specifically modified herein, the Agreement shall remain in full force and effect as originally executed.
5. This First Amendment shall be binding on the successors and assigns of the Parties hereto and shall run with the term of the Agreement.
