**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT
FIRST EXTENSION & MODIFICATION**

On July 1, 2022, the Milwaukee Board of School Directors and Marquette University entered into Professional Services Contract number C030679 (“Contract”), with a term of August 1, 2022 through July 31, 2023. The Contract, Section 2, provided for additional extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor’s achievement of those performance metrics, the parties now mutually agree to extend the Contract for a three-year term.

As such, the Contract will be extended for a three-year term, from August 1, 2023 through July 31, 2026 (Years 2, 3, and 4), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 1, Scope of Services, is modified to include the following additional language: “During years 2, 3, and 4, there will be a gradual phase in of early year grade levels to Success Center services beginning with grade 3 in the 2023-2024 school year, grades 1 and 2 beginning with the 2024-2025 school year, and grades K4 and K5 in the 2025-2026 school year.
2. Section 2, Term, is modified to include the following language: “The Contract is extended for Years 2, 3, and 4, with a term of August 1, 2023 through July 31, 2026.”
3. Section 3 of the Contract is modified to include the following additional language: “Total compensation in Years 2, 3, and 4 shall not exceed \$4,583,049.”
