The Independent Hearing Officer of the Milwaukee Board of School Directors met at **9:30 a.m.** on **Thursday, May 25, 2017**, in Room 136 of Milwaukee Public Schools' Central Services Building, to give hearing regarding the recommendation of Mr. Matthew Boswell, Senior Director of the Department of Student Services, to expel **••••**, who was accused of **Possession of Drugs – Marijuana (Brownies) with the Intent to Distribute at South Division High School on Friday, May 5, 2017.**

After hearing testimony and taking evidence, the Officer appointed by the Board of School Directors finds as follows:

By **Possession of Drugs – Marijuana (Brownies) with the Intent to Distribute at South Division High School on Friday, May 5, 2017**, **••••** engaged in conduct while at school and while under the supervision of a school authority, which endangered the property, health and safety of others while at school and under the supervision of a school authority. Such conduct is grounds for expulsion under Wisconsin State Statute 120.13 (1)(c).

Based on these findings, the recommendation of the Senior Director of the Department of Student Services, to expel **••••** is reasonably justified; and the interests of the Milwaukee Public Schools demand that this student be expelled until **June 30, 2018**. Reinstatement into the Milwaukee Public Schools will be through the Department of Student Services.
