#### MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT SECOND EXTENSION & MODIFICATION

On June 1, 2019, the Milwaukee Board of School Directors and Robert Munger d/b/a Munger Technical Services entered into Professional Services Contract number B0001376 ("Contract"), with a term of June 1, 2019 through May 31, 2020. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. The parties previously extended the contract for the first one-year term (the "First Extension"), from June 1, 2020 through May 31, 2021. - 1. Paragraph 3 of the Contract is modified to include the following provision: "Total compensation under this Contract for the term of June 1, 2021 through May 31, 2022 ("Year 3") shall not exceed \$275,000.00."
- 2. Paragraph 3 is modified to include the following provision: "Pricing for additional goods and services related to those defined in RFP 1010 shall be provided in accordance to Contractor's "Quote # V307 v2" attached hereto as Exhibit A, and herein incorporated by reference."
