SUPPLEMENTAL BLANKET AGREEMENT

This Agreement, along with AEPA IFB #018-A Technology Catalog and its Form B – Acceptance of Bid & Contract Award executed by Contractor and CESA, constitutes the entire agreement between the parties relating to the subject matter of this Agreement. All prior understandings, agreements, correspondence and discussions of the parties are merged into and made a part of this Agreement. To the extent that the terms of the documents conflict, the terms of this Agreement shall control.

Total compensation under this Agreement will not exceed \$1,500,000.00.

No amendment or modification of any provision of this Agreement shall be effective unless the same shall be in writing and signed by authorized signatories of both parties.
