**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT
THIRD EXTENSION & MODIFICATION**

On December 7, 2021, the Milwaukee Board of School Directors and ENA Services, LLC entered into Professional Services Contract number C030294 (“Contract”), with a term of July 1, 2022 through June 30, 2023. The Contract, Section 2, provides for the possibility of four additional one-year extension terms to be exercised solely at the discretion of MPS. MPS subsequently exercised the first and second extensions, extending the contract through June 30, 2025. The parties now mutually agree to extend the Contract for a fourth one-year term.

As such, the Contract will be extended for a fourth term, from July 1, 2025 through June 30, 2026 (“Year 4”), under the same terms and conditions as set forth in the original Contract and First and Second Extensions, except for those specifically set forth below. Exhibit A to the Contract, which remains unchanged, is attached hereto for reference.

In accordance with Section 19 of the Contract, the parties modify the terms identified below:

MODIFIED TERM:

1. Section 2(A) of the Contract is modified as follows: Subsection 2.A.iii is added which states “Year 4. This Contract shall be extended for a fourth term from July 1, 2025 through June 30, 2026.”
2. Section 3(A) of the Contract is modified as follows: Subsection 3.A.iii is added which states “Year 4. The total costs of the services under this Contract shall not exceed \$247,200 for the term July 1, 2025 through June 30, 2026.
