Goodwill's provision of substitute teachers is to augment existing efforts to recruit substitute teachers, given our current substitute teacher vacancy-fill rate of 84%. Additional positions Goodwill provides include, but are not limited to: custodial, secretarial/clerical, food service, safety assistants, children's health assistants, school nurse associates, bookkeepers, and technology positions. Goodwill will also continue to provide substitute dispatching services.

This contractor was chosen pursuant to RFP 865. The original contract provided for two one-year options to extend. This will be the second and final option.

This contract extension will run from February 1, 2017 through January 31, 2018. The total cost of the contract in this extension year will not exceed \$6,442,800.

RFP 923 Authorization to Increase Funds for the Blanket Contract with Arts at Large, Inc. for Arts Education Programming

The Administration is requesting authorization to increase funds for the blanket contract with Arts at Large, Inc., (A@L) to continue to arts education programming as part of the "Fill the Gaps" initiative.

The Fill the Gaps initiative was developed to utilize funds from unfilled, budgeted positions for licensed music and arts teachers as contracted services to serve as temporary arts instruction for students. RFP 923 was developed to solicit arts programming to fill any gaps which may exist in the 2016-17 school year. Six contractors were chosen pursuant to RFP 923, and were awarded contracts with terms of October 1, 2016 through September 1, 2017 with the option to extend for up to two additional one-year terms.

One of those vendors, A@L, was awarded a blanket contract with an amount not too exceed \$500,000.00 in the initial term. Currently, the blanket contract with Arts at Large has been encumbered by schools in the amount of \$499,772.03. Schools are still in need of art education services, and A@L is the only remaining contractor from RFP 923 who is not at service capacity within the District.

The Administration requests an increase of \$350,000 to this contract for additional services.
