ARTICLES OF INCORPORATION

OF

HIGHLAND COMMUNITY SCHOOL, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a Wisconsin non-profit corporation under Chapter 181 of the Wisconsin Statutes:

**I**

The name of the Corporation is "Highland Community School, Inc."

**II**

The period of existence of the Corporation shall be perpetual.

**III**

The Corporation is organized exclusively for charitable and educational purposes, for the use and benefit of the people and community generally centered in that area of the City of Milwaukee bounded by West Galena Street, North 12th Street, West State Street and North 27th Street as well as other adjacent and contiguous areas of said City, provided that no part of the net earnings of

the Corporation shall inure to the benefit of any private individual and no substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate or intervene, including the publishing or distributing of statements, in any political campaign on behalf of any candidate for public office. ~~laws of the State of Wisconsin shall be laws that~~

IV

The Corporation shall have one class of members, and all members shall have an equal right to vote. Any members of the staff of Highland Community School, Inc. and any parent having a child enrolled in Highland Community School shall be eligible for membership in the Corporation. Such persons shall be admitted to membership upon the affirmative vote of a majority of the members of the Corporation's Board of Directors. The qualifications for membership and the manner of electing members may hereafter be changed from time to time by the By-Laws of the Corporation.

V

The principal office of the Corporation shall be located in Milwaukee, Wisconsin. The address of the registered <sup>AGENT</sup> office of the Corporation is 2004 West Highland, Milwaukee, Wisconsin <sup>53223</sup> and

the name of the registered agent at such address is Michael R. Williams.

VI

The number of Directors constituting the initial Board of Directors of the Corporation shall be three (3). The number of Directors of the Corporation may be changed from time to time by the By-Laws of the Corporation, but in no case shall be less than three (3).

VII

The names and addresses of the persons who are to serve as Directors until their successors are elected and shall qualify are:
