Meeting of the District Advisory Council Thursday, October 1, 2020 Virtual Meeting

WELCOME AND EXECUTIVE COMMITTEE INTRODUCTIONS

Chairperson Tracey Dent solicited introductions from each executive board member who was presently on zoom.

CONSENT AGENDA

There were problems with some members being able to log in to the meeting. LaTashsa Grimes and Jane Konkel offered suggestions for those who are new to virtual meetings including watching the tutorial. Many suggestions were given so that all members will be able to login by zoom or phone. Many people were unable to log in initially.

Jenni Hofschulte apologized for the glitches and suggested members use the mymps.org website for information and surveys to help parents convey their interests and concerns to DAC members.

Lori Albers motioned to have March minutes reviewed for corrections and approval at next DAC meeting. Seconded by Charles Manning. Motion carried. Minutes will be made available on district website.

POSITIVE NOTES

Positive notes were solicited by Chairperson Tracey Dent:

- Ms. Deaduri Gales, Martin Luther King Elementary, commented on the first virtual dance party at their school. It was well attended and everyone enjoyed it.
- 2) **Miss Johnson, Douglass:** The school had a drive through open house and new Chrome book distribution. They received a Vills (?) Grant. Seventy one parent surveys were completed and over a hundred families came to pick up Chrome books.
- 3) Nikki Johnson, Parent Coordinator, Goodrich: Two weeks ago students were able to pick up learner bags that included dry erase boards, cubes, markers and goody bags to help students with virtual learning.
- 4) Teresa Davis, Maple Tree Elementary: Had a virtual sock hop for third Friday event.
- 5) **Ms Rivera, Riley School:** For the third Friday, Riley had a dance activity and a physical activity. The attendance was increased by 8% for that day.
- 6) **Dawn Collins, Engelburg**: Completed their first virtual Title I meeting, right before this meeting. Briana Hernandez, Parent Coordinator, Fairview School: Was able to obtain

McDonald's coupons for students as a thank you for participating in Friday activities. Recorded a video of teachers during Spirit Week that students were able to watch. They had over 1200 coupons to give to families.

- 7) **Renee Huber Hicks:** During spirit week we had activities each day. Each day attendance rose and staff was hyped. Gave out a number of incentives for students' good work and attendance. Marcus theater movie passes and calculators were among the many things given to the students.
- 8) Cassandra Holmes, Parent Coordinator, Pulaski High School: They have a full service automotive program that is expanding to doing body shop work in the future. They also have careers and diploma programs going. They made their monthly numbers.
- 9) **Andy Kilimann** suggested that members who have more positive notes put them in the chat area so that they can be put in the next Consent Agenda.

DAC MEMBER ORIENTATION

Jenni Hofschulte gave an overview of the purpose of the DAC and why it is important for parents and community to participate. Parents are the most trusted partners of the school district. DAC provides a monthly forum for families to come together and share the good things happening at their schools, receive information about district policy and activities and to discuss matters of concern regarding their students'/school's progress. The DAC provides feedback to the district decision makers from parents and other community shareholders. New members need to know how important it is to attend the monthly meeting and bring the concerns and interests of your school community forward for sharing. In addition, you will be bringing back information to your school. The district often provides presentations about subjects that affect our schools and it is really important that you, as your school's DAC representative, distribute that information to your school community by phone, mail, flyers, email, etc., or whatever means will work for you. As a representative, you'll work with your school's parent coordinator. Become active in DAC by serving on committees and encouraging other parents to get involved.

NEW BUSINESS - JENNI HOFSCHULTE

Currently, DAC by-laws require that we meet in person at Central Office on the first Thursday of each month. DAC did not meet in April or May, 2020, due to the emergency closure orders from the governor. With Central Office closed, and the prospect of limited occupancy when it does reopen, we may need to meet virtually for some time. The Executive Committee would like the DAC to vote on continuing virtual meetings until further notice.

It was moved by Charles Manning for the DAC to meet virtually for the 2020-21 year and the first meeting of the 2021-22 school year, if the chair sees fit to do so, to hold the initial meeting of that (2022) school year to prevent the spread of the COVID virus and follow potential restraints as set by law on large gatherings. Seconded by Andy Kilimann.

Discussion

Angela Rappl, Fairview, had questions about how small group meetings and the introducing of special committees by parents could proceed in a virtual environment.

There were also questions about whether this amendment, as presented by Mr. Manning, is in accordance with DAC by-laws. Andy Killimann, by-law committee member indicated that the amendment, as stated, could stand.

A link was to be put in the Chat for members to vote. Many members voted just using the Chat. Results of the vote will be available, through email, to the membership before the next meeting.

Committee Openings

There are committee openings that need to be filled including Election and By-Laws, Standing Committees on Family Action and Training. Anyone interested should send an email to DAC at milwaukee@k12.wi.us and indicate on which committee you would like to serve. If you would like to serve on a special topic committee, please indicate that through the email. The Executive Committee is working on how to facilitate the small groups and special committees. Jenni also discussed Executive Committee openings for Vice Chair, Communications Secretary, Parliamentarian, and At-Large Member. If any members, with at least one-year tenure on DAC, are interested please indicate such through the district email to Executive Committee. Descriptions and duties of each position are available in your October meeting information. The vote on these positions may be completed at the November meeting.

Therefore, interested members have a few weeks to submit their choice for review.

ADJOURNMENT

- 1. It was moved by Nonita Stiggers and seconded by Charles Manning that the meeting be adjourned.
- 2. Unreadiness: Bama Grice, Parent Coordinator, 81st Street School: Do the Title I school meetings have to be two hours long or can they be shortened since they are virtual.
- 3. Darryl Hall: If you are using Title I funds, the meeting must be two hours long and there must be a sign-in sheet, and a flyer. Ms. Grice will contact Mr. Hall for additional information.




