#### MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT FIRST EXTENSION & MODIFICATION

On August 1, 2019, the Milwaukee Board of School Directors and Dairyland Buses, Inc.. ("Contractor") entered into a Professional Services Blanket Contract number C028812 ("Contract") with a term of August 1, 2019 through July 31, 2020. The Contract, ( $\P$  2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor's achievement of those performance metrics, the parties now mutually agree to extend the Contract for the first one-year term.
