PROFESSIONAL SERVICES CONTRACT  
SIXTH MODIFICATION

On August 1, 2017, the Milwaukee Board of School Directors and Airoidi Brothers, Inc. entered into Professional Services Contract number C026593 with a term of September 1, 2017 through August 31, 2018, which was subsequently extended September 1, 2018 and July 25, 2019, and ("Contract"). The Contract, provided for four additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor's achievement of those performance metrics, the parties now mutually agree to extend the Contract for the seventh one-year term.

As such, the Contract will be extended for the seventh additional one-year term, from September 1, 2023 through August 31, 2024 ("Year 7"), under the same terms and conditions as set forth in the original Contract, and all applicable extensions and modifications, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 2, Term, of the Contract is modified, striking the language "August 31, 2018" and replacing with "August 31, 2024".
2. Section 3, Compensation, of the Contract is modified to include the following provision: "Total compensation under this Contract for the period from September 1, 2023 through August 31, 2024 ("Year 7"), shall not exceed \$350,000.00."
