PROFESSIONAL SERVICES CONTRACT  
SECOND CONTRACT EXTENSION AND MODIFICATION**

On November 1, 2020, the Milwaukee Board of School Directors and Wisconsin Conservatory of Music entered into Professional Services Contract number C029724 (“Contract”), with a term of November 1, 2020 through June 30, 2021. The Contract, provided for two additional one-year extensions upon the mutual written consent of parties. The Contract was subsequently extended for the first one-year term, from July 1, 2021 through June 30, 2022. Based on the Contractor’s achievement of those performance metrics, the parties now agree to extend the Contract for the second remaining term.

As such, the Contract will be extended for the second additional one-year term, from November 1, 2022 through June 30, 2023, under the same terms and conditions as set forth in the original Contract except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

**MODIFIED TERMS:**

1. Section 2, Term is modified, striking the language “June 30, 2022” and replacing with “June 30, 2023”.
2. Section 3, Compensation is modified to include the following provision: “Total compensation under this Contract shall not exceed \$700,000.00.”
3. The Contract is modified to change the existing Contract to a Blanket Contract, resulting in a change to the Contract number from C029724 to Blanket Contract B0001511.
