On February 28, 2014, the Milwaukee Board of School Directors and McCain Foods USA, Inc., entered into Blanket Contract ("Contract") number B0001135, with a term of July 1, 2014 through June 30, 2015. The Contract, ¶ 2, provided for up to four additional one-year extensions by mutual consent and with Board approval. The parties mutually agreed to extend the Contract for the first and second one-year extension periods and executed Contract Extension and Modifications ("the First Extension" and "the Second Extension") to that effect in July 2015 and July 2016, respectively.

All other text of Paragraph 1 of the Contract, Paragraph 1 of the First Extension and Paragraph 1 of the Second Extension remains unchanged.
