All prior understandings, agreements, correspondence and discussions of the parties are merged into and made a part of this Agreement. To the extent that the terms of the documents conflict, the terms of this Supplemental Agreement shall control.

Total compensation under this Supplemental Agreement will not exceed \$300,000.00.

No amendment or modification of any provision of this Supplemental Agreement shall be effective unless the same shall be in writing and signed by authorized signatories of both parties.
