# **DAC ORIENTATION**

Kevin Curley led an orientation for new members. He welcomed new members and gave a slide presentation.

Tom Mueller from MICAH as who chooses the informational items? He was informed that, although the Executive Committee sets the agenda, parents and the district may suggest topics. Ideas, thoughts, etc. may be submitted to dac@milwaukee.k12.wi.us.

Representatives Rachel Kenison, Javier Cornejo, and Kate Deluedo gave examples of how they gather and share information at their schools.

- Rachel Kenison said that she attends meetings of the School Engagement Council (SEC) and the PTA.
- Javier Cornejo of Bay View said that he speaks to the principal and the parent coordinator, who consult with the SEC, then send emails, surveys, etc.
- Kate Deludeo uses social media as an avenue to sharing information.

DAC's impacts at MPS were reviewed. Over the past few years, the DAC has given voice on bell and bus schedules, bullying policies, facilities plans, children's savings accounts, the MPS equity policy, school-uniform policies, calendar changes, changes to the school governance/school engagement councils, parent-empowerment policies, and the district's budget. Parents are encouraged to bring forward ideas for discussion at the committees of the Milwaukee Board of School Directors.

Director Paula Phillips was introduced as the Milwaukee Board of School Directors' delegate to DAC, After introducing her new baby, Director Phillips said, "I love being part of the Board and I am willing to hear you out from any school in the district. Don't hesitate to reach out."

This is an information-sharing group. We will be giving you a lot of information, and we want to hear from parents and the community. Support is offered by the DAC's Executive Committee, schools' parent coordinator, and the FACE Team. Parent coordinators are a dedicated group — reach out to them and work with them. Tracy Dent reminded those present that October is Bullying-awareness month and that October 25 is Unity Day, on which people are encouraged to take action against bullying by wearing orange.

### **EXECUTIVE COMMITTEE'S OPEN POSITIONS & NOMINATION FORM**

Open positions on the Executive Committee were reviewed. Angela Riley from Reagan asked for further explanation of the Executive Committee's commitments. She was told that the members are all here to support one another. For example, Tracy Dent, who had joined the Executive Committee a few years ago, started the anti-bullying *ad-hoc* committee which has led to the city-wide taskforce. Andy Kilimann of Fairview further explained that Tracy had headed up the bullying-prevention taskforce at the city level, having met since May with city officials and bullying experts. This great work came from a subcommittee of the DAC.

Tracy Dent stated that parents are a powerful force and should be using their voices to influence change.

Jenni Hofschulte explained that the Executive Committee meets in the week prior to the DAC to set the agenda, and committee members are expected to assist with subcommittees and discussion groups. Members also represent the DAC at district meetings or events,

## INTRODUCTION OF ANGELA RAPPLE

Angela Rapple from Reagan is representing Milwaukee on the State Superintendent of Schools's parent advisory committee. She reported that the September meeting's takeaways included the following goals for our Wisconsin public schools:

increase school funding

- train staff to understand community and cultural differences
- education equity and closing gaps
- approaching teaching and learning differently
- reducing class size
- "ditching punishments" for "addressing needs"
- implicit bias training opportunities "Project Implicit," https://implicit.harvard.edu/implicit
- improving materials students having outdated materials leads to gaps in learning and grade-level achievements

DPI has used the data from edreports.org, a think tank that is supported wealthy philanthropic families who do not support public education. We need to make sure that we recognize that, if as a state we are going to move forward on materials, it must come from the right place, and not from folks who do not support public education.
