CONTRACT

COMMODITY OR SERVICE: Education, Classroom, Miscellaneous Support Furniture and Related products

PERIOD OF CONTRACT: 10/1/2023 through 12/31/2026

This contract is entered into by and between the Milwaukee Board of School Directors (“MPS”) and Virco, Inc. (“Contractor”).

Whereby, MPS agrees to direct the purchase and Contractor agrees to supply such requirements of the commodity or service cited above in accordance with the Omnia Partners Contract R-TC-18004. This Contract is subject to any amendments to that Contract executed in the future. This Contract is made possible due to the mutual membership of MPS and Virco, Inc. to the nationwide cooperative, Omnia Partners.

Contractor acknowledges and agrees that the relationship with MPS is non-exclusive and MPS may contract with as many additional entities as MPS, in MPS’s sole discretion, sees fit.

In accordance with MPS Administrative Policy 3.10, which is hereby incorporated by reference, the following requirements have been assigned to this Agreement: the HUB requirement on this Contract is 0%; the Student Engagement requirement of this Contract is 400 hours per 38-month term; and the Career Education requirement for this Contract is 10 hours per 38-month term. Failure to achieve these requirements may result in the application of some or all of the sanctions set forth in Policy 3.10.

This Contract, along with Omnia Partners Contract R-TC-18004 and Virco, Inc. attachment 1, constitutes the entire agreement between the parties relating to the subject matter of this contract. All prior understandings, agreements, correspondence and discussions of the parties are merged into and made a part of this Contract.

Total compensation under this Contract will not exceed \$1,000,000.00.

No amendment or modification of any provision of this Contract shall be effective unless the same shall be in writing and signed by authorized signatories of both parties.
