MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT SECOND EXTENSION & MODIFICATION

On July 1, 2019, the Milwaukee Board of School Directors and Literacy Services of Wisconsin, Inc. entered into Professional Services Contract number C028767 ("Contract"), with a term of July 1, 2019 through June 30, 2020. The Contract, (\P 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. The Contract was previously extended for the first one-year term (the "First Extension") from June 30, 2021 through July 1, 2022. Based on the Contractor's achievement of those performance metrics, the parties now mutually agree to extend the Contract for the second and final one-year term.

As such, the Contract will be extended for the second additional one-year term, from July 1, 2021 through June 30, 2022 (the "Second Extension"), under the same terms and conditions as set forth in the original Contract except for those specifically modified below.

In accordance with (¶ 20) of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

- 1. Paragraph 1, Scope of Services, is modified to include the following additional language as item (i): "Contractor will follow the guidance of MPS and its Board of School Directors in determining the degree of in-person programming that can occur onsite at the designated MPS locations. The service delivery format is mutually agreed upon between CONTRACTOR and MPS, and may consist of a combination of face-to-face and virtual learning options, as appropriate. Virtual learning will primarily be synchronous, occurring in one-on-one or group environments online. Asynchronous learning will be used primarily in a supplemental capacity. In returning to the classroom, CONTRACTOR will work closely with MPS to create a post-COVID transition plan for in-person programming that considers the square footage of CONTRACTOR's assigned MPS learning spaces, and determines safe limits for the size of small group classes and the maximum number of adult students served per day. This transition plan will be created for each MPS school where CONTRACTOR is collocated and mirror the district's "Roadmap to Readiness." CONTRACTOR will be prepared to transition any in-person services to virtual programming at any time if a staff member or student is exhibiting symptoms or tests positive for COVID-19.
- 2. Paragraph 3, Compensation, is modified to include the following provision: "Total compensation under this Contract for the term of July 1, 2021 through June 30, 2022 ("Year 3") shall not exceed \$130,000.00."
