SUBJECT: Per Pupil Revenue Limit Adjustment and Per Pupil Aid Increases, 1993-94 to 2022-23

At your request, I am providing information about additional resources provided to school districts on a per pupil basis under revenue limits and per pupil aid in each year beginning in 1993-94 and ending with resources provided in 2021-22 and 2022-23 under 2021 Act 58 (the 2021-23 biennial budget act). The table below shows the annual combined resource change from the per pupil revenue limit adjustment, and the change in the per pupil aid payment relative to the prior year since per pupil aid was created in 2012-13.
