**MILWAUKEE BOARD OF SCHOOL DIRECTORS  
PROFESSIONAL SERVICES CONTRACT  
SECOND EXTENSION & MODIFICATION**

On September 1, 2020, the Milwaukee Board of School Directors and GPS Education Partners, Inc entered into Professional Services Contract number C029595 (“Contract”), with a term of September 1, 2020 through August 31, 2021. The Contract was subsequently extended for an additional one-year term of September 1, 2021 through August 31, 2022. The parties now mutually agree to extend the Contract for the second and final additional one-year term.

As such, the Contract will be extended for the second additional one-year term, from September 1, 2022 through August 31, 2023 (“Year 3”), under the same terms and conditions as set forth in the original Contract and the First Extension, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

**MODIFIED TERMS:**

1. Section 1 of the Contract is modified to include the following changes:  
 Paragraph 1, line 1: Contractor shall provide enrollment for up to thirty (30)...  
 Paragraph 1, line 9: As many students as possible up to 30,....  
 Paragraphs 2, 3, 4 (and numerical bullets), 5, 6, and 7 are hereby deleted.
2. Section 2 of the Contract is modified to include the following additional sentence,  
 “The Contract is extended for a third one-year term from September 1, 2022 through August 31, 2023 (Year 3).”
3. Section 3 of the Contract is modified to include the following provision: “Total compensation under this Contract shall not exceed \$120,000.00.”
