## MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT EXTENSION & MODIFICATION

On February 28, 2014, the Milwaukee Board of School Directors and Red Gold, LLC entered into Professional Services Contract number B0001129, with a term of July 1, 2014 through June 30, 2015. The Blanket Contract, ¶ 2, provided for up to four additional one-year extensions by mutual consent and Board approval.
