FIRST EXTENSION & MODIFICATION**

On July 1, 2018, the Milwaukee Board of School Directors and Edgenuity, Inc. ("Contractor") entered into Professional Services Contract number B0001328 ("Contract") with a term of July 1, 2018 through June 30, 2019. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. 




