MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT EXTENSION & MODIFICATION

On February 28, 2014, the Milwaukee Board of School Directors and JTM Provisions Co., Inc. entered into Professional Services Contract number B0001134, with a term of July 1, 2014 through June 30, 2015. Failure to achieve these requirements may result in the application of some or all of the sanctions set forth in Administrative Policy 3.10, which is hereby incorporated by reference."
