PROFESSIONAL SERVICES CONTRACT
FIRST CONTRACT EXTENSION & MODIFICATION**

On July 1, 2022, the Milwaukee Board of School Directors and Board of Regents of the University of Wisconsin System on behalf of University of Wisconsin-Milwaukee entered into Professional Services Contract number C030699 (“Contract”), with a term of July 1, 2022 through June 30, 2023. The Contract, provided for two additional one-year extensions upon the mutual written consent of parties.

As such, the Contract will be extended for the first additional one-year term, from July 1, 2023 through June 30, 2024, under the same terms and conditions as set forth in the original Contract except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 1, Scope of Services is modified, adding the language “ In Fall, UWM instructors shall provide a one credit Educational Psychology support course on the MATC campus. This course will focus on acclimating students for college success.”.
2. Section 2, Term is modified as follows: “ This Contract shall be in effect July 1, 2023 through June 30, 2024 (Year 2).”
3. Section 3, Compensation is modified as follows: “Total compensation under this Contract shall not exceed \$231,391.62 in Year 2, payable as follows:
*Cost per 3 credit course/section shall be \$12,575.00. Up to 14 sections shall take place, totaling \$176,050
*Cost per 1 credit course shall be \$4,191.66. Up to 7 sections shall take place, totaling \$29,341.62
