New Business

- Program Updates-Information Item:
 - MPS Kindergarten Enrollment Fair will take place on Saturday, February 3, 2024 from 9 A.M. - 12:00 P.M. at South Division. The Head Start program will be able

to register families interested in the Head Start program. All MPS schools will be represented at this enrollment event.

- Active Supervision:
 - Krissy Washington, Early Learning Manager shared the importance of active supervision. Ms. Washington shared the six strategies and examples in: set up the environment, position of staff, listen, anticipate children's behavior, engage and redirect, and scan and count. Active supervision will benefit when children are with parents/guardians and outside of the school environment. Information regarding active supervision has been shared with school leaders, teachers but also with transportation and bus drivers. Policy Council members were given the link to the Active Supervision poster.
 - Albert Robbins Jr asked if there is an additional cost for active supervision? Krissy Washington, Early Learning Manager stated the active supervision strategies are free and there is no additional cost to the Head Start program.
