On July 1, 2020, the Milwaukee Board of School Directors and Owners Group d/b/a Learning Exchange entered into Professional Services Contract number C029511 ("Contract"), with a term of July 1, 2020 through June 30, 2021. The Contract was modified via a modification (the "First Modification") to include the Elementary and Secondary School Emergency Relief (ESSER) services. The Contract was modified via a modification (the "Second Modification") to include the Governors Emergency Education Relief (GEER) services. The Contract was modified via a modification (the "First Extension & Modification") to extend the Contract for a second term, from July 1, 2021 through June 30, 2022 ("Year 2") and to add additional funds.

MODIFIED TERMS:

- 1. Section 3, Compensation, is modified to include the following provision: "Total compensation under this Contract for the period from July 1, 2021 through June 30, 2022 ("Year 2"), will increase by \$6,026,763.23 from \$16,486,349.97 to \$22,513,113.20."
