**MILWAUKEE BOARD OF SCHOOL DIRECTORS  
PROFESSIONAL SERVICES CONTRACT  
SECOND EXTENSION AND MODIFICATION**

On July 1, 2022, the Milwaukee Board of School Directors and Specialized Care Transport, Inc. entered into Professional Services Contract number C029884 (“Contract”), with a term of July 1, 2021 through June 30, 2022. The Contract, Section 2, provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. The Contract was previously extended for the first one-year term (the “First Extension”) with a term of July 1, 2022 through June 30, 2023. Based on the Contractor’s achievement of those performance metrics, the parties now mutually agree to extend the Contract for the second and final one-year term.

As such, the Contract will be extended for the second and final additional one-year term, from July 1, 2023 through June 30, 2024 (“Year 3”), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

**MODIFIED TERMS:**

1. Section 2, TERM, is modified to include the following provision: “This Contract shall be in effect from July 1, 2023 through June 30, 2024 (“Year 3”).”
2. Section 3, COMPENSATION, of the Contract is modified to include the following 5% CPI increase provision to Contractor’s pricing:
