PROFESSIONAL SERVICES CONTRACT
FOURTH EXTENSION & MODIFICATION**

On August 1, 2017, the Milwaukee Board of School Directors and Airolodi Brothers, Inc. entered into Professional Services Contract number C026593 with a term of September 1, 2017 through August 31, 2018, which was subsequently modified September 1, 2018 and July 25, 2019 ("Contract"). The Contract, (¶ 2), provided for four additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor's achievement of those performance metrics, the parties now mutually agree to extend the Contract for the fourth one-year term.


As such, the Contract will be extended for the fourth additional one-year term, from September 1, 2021 through August 31, 2022 ("Year 5"), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with ¶ 30 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Paragraph 1 of the Contract is modified to include up to twelve (12) 2018 Isuzu NQR Refrigerated Trucks (each a "vehicle" and together the "vehicles") in accordance with the specifications set forth in § 2.1.2 of RFP 945, and on the terms set forth herein.
2. Paragraph 3 of the Contract is modified to include the following provision: "Total compensation under this Contract for the period from September 1, 2021 through August 31, 2022 ("Year 5"), shall not exceed \$320,000.00."
