**MILWAUKEE BOARD OF SCHOOL DIRECTORS  
PROFESSIONAL SERVICES CONTRACT  
FIRST EXTENSION**

On August 1, 2021, the Milwaukee Board of School Directors and Maxim Healthcare Staffing Services, Inc. entered into Professional Services Contract number C030040 (“Contract”), with a term of August 1, 2021 through July 31, 2022. The Contract, Section 2, provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed therein. Based on the Contractor’s achievement of those performance metrics, the parties now mutually agree to extend the Contract for the second and third one-year terms.

As such, the Contract will be extended for the first and second additional one-year terms, from August 1, 2022 through July 31, 2024 (Years 2 and 3), under the same terms and conditions as set forth in the original Contract and First Modification, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

**MODIFIED TERMS:**

1. Section 2, **Terms**, shall be modified as such: “This Contract extension of the Initial Term shall be in effect from August 1, 2022 through July 31, 2024 (Years 2 and 3).”
2. Section 3, **Compensation**, shall be modified as such, “Total compensation for Year 2 and 3 extensions under this Contract shall not exceed \$600,000 (\$300,000 for Year 2 and \$300,000 for Year 3).
