## MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT SECOND EXTENSION & MODIFICATION

On July 1, 2017, the Milwaukee Board of School Directors and Proximity Learning, Inc. entered into Professional Services Contract number B0001284, with a term of July 1, 2017 through June 30, 2018. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties and in consideration of the Performance Objectives listed therein. The parties mutually agreed to the first one-year extension (the "First Extension").
