MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT EXTENSION & MODIFICATION

On February 28, 2014, the Milwaukee Board of School Directors and Red Gold, LLC entered into Professional Services Contract number B0001129, with a term of July 1, 2014 through June 30, 2015. The Blanket Contract, ¶ 2, provided for up to four additional one-year extensions by mutual consent and Board approval. The Career Education requirement for this Contract is 0 hours. Failure to achieve these requirements may result in the application of some or all of the sanctions set forth in Administrative Policy 3.10, which is hereby incorporated by reference."
