THIS THIRD AMENDMENT TO LEASE ("Third Amendment") is made as of the day of \_\_\_\_\_\_\_, 2023, by and between THE MILWAUKEE BOARD OF SCHOOL DIRECTORS (hereinafter "the Board") and LIT'L SCHOLARS DAY CARE (hereinafter "Lessee").

### RECITALS

**WHEREAS**, the Board and Lessee entered into that certain Lease dated August 30, 2013; and

**WHEREAS**, the Board and Lessee entered into that certain First Amendment to the Lease dated June 28, 2018; and

**WHEREAS,** the Board and Lessee entered into that certain Second Amendment to the Lease dated June 29, 2023; and

**WHEREAS**, the Board and Lessee wish to amend the Lease as set forth below.

**NOW, THEREFORE,** the parties hereto agree as follows (all capitalized terms used but not defined herein shall have the meaning set forth in the Lease):

- 1. Section 2 of the Lease is hereby deleted and replaced with the following:
  - 2. <u>TERM:</u> The term shall commence on September 1, 2024 and will terminate on August 31, 2025, except either party may terminate the lease by providing the other party 60-day written notice of termination. Upon termination, Lessee shall vacate the Premises in a manner consistent with the terms and conditions of this Lease.
- 2. Section 5 of the Lease is hereby deleted and replaced with the following:
  - 5. <u>RENTAL</u>: Lessee shall pay a rental fee to the Board as follows:
    - a. Year one: \$44,751.20. Rent shall be payable in twelve (12) equal monthly payments on the first of each month.
    - b. First and last months payment is due five (5) days prior to the commencement date of this agreement.
    - c. Rent is to be paid to: Milwaukee Public Schools, Facilities and Maintenance Services, 1124 North 11<sup>th</sup> Street, Milwaukee, Wisconsin, 53233, Attention: Director.
- 3. Except as modified by this Third Amendment, the Lease shall continue in full force and effect as provided therein.
