PROFESSIONAL SERVICES CONTRACT
FOURTH MODIFICATION**

On May 1, 2023, the Milwaukee Board of School Directors and Summit Clinical Laboratories, LLC entered into Professional Services Contract number C031537 (“Contract”), with a term of May 1, 2023 through June 30, 2023. The Contract was subsequently extended from July 1, 2023 through June 30, 2024.

As such, the Contract will be extended for the second one-year term, from July 1, 2024 through June 30, 2025, under the same terms and conditions as set forth in the original Contract except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 1, SCOPE OF SERVICES is modified, to add the following paragraph: “Contractor shall provide paraprofessionals that hold at least 48 college credits or successfully pass the parapro assessment to serve as paraprofessionals in MPS schools. In addition, the Contractor’s employees shall be used as classroom coaches for Elevate K12 classrooms. Contractor shall also provide a monthly report showing employees who have met the 350 hours and are eligible for hire with MPS”.
2. Section 2, TERM is modified, to add the following sentence: “This Contract shall be in effect from July 1, 2024 through June 30, 2025.”
3. Section 3, COMPENSATION is modified to include the following provision: “Total compensation for the third term shall not exceed \$1,000,000.00.”
