**MILWAUKEE BOARD OF SCHOOL DIRECTORS
PROFESSIONAL SERVICES CONTRACT
SEVENTH MODIFICATION**

On August 1, 2017, the Milwaukee Board of School Directors and Airoidi Brothers, Inc. entered into Professional Services Contract number C026593 ("Contract"), with a term of September 1, 2017 through August 31, 2018, which was subsequently extended to September 1, 2018 and July 25, 2019, and ("Contract"). The Contract, provided for four additional one-year extensions upon mutual written consent of the parties and in consideration of the performance metrics listed herein.

As such, the Contract will be extended for the eight additional one-year term, from September 1, 2024 through August 31, 2025 (Year 8), under the same terms and conditions as set forth in the original Contract, except for those specifically modified below.

In accordance with Section 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. Section 1, Scope of Services, of the contract is modified, adding the additional language: MPS shall use up to seven trucks and one van during the length of this extension. The remaining three trucks shall be returned to the Contract before the start of this extension. MPS shall also return existing trucks back to the Contractor as new trucks become available in conjunction with RFP 1096.
2. Section 2, Term, of the Contract is modified, striking the language "August 31, 20218" and replacing with "August 31, 2025".
3. Section 3, Compensation, of the Contract is modified to include the following provision: "Total compensation under this Contract for the term of September 1, 2024 though August 2025 ("Year 8"), shall not exceed \$350,000.00."
