MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT SECOND EXTENSION & MODIFICATION

On February 28, 2014, the Milwaukee Board of School Directors and Michael Foods, Inc., entered into Blanket Contract ("Contract") number B0001136, with a term of July 1, 2014 through June 30, 2015. The Contract, \P 2, provided for up to four additional one-year extensions by mutual consent and with Board approval. Contractor did not provide services to MPS for the term of July 1, 2015 through June 30, 2016. Notwithstanding that break in services, the parties mutually agreed to extend the Contract for the first one-year extension period and executed a Contract Extension and Modification ("the First Extension") to that effect in July 2016.

The parties now mutually agree to extend the Contract for an additional one-year term, from July 1, 2017 through June 30, 2018, under the same terms and conditions as set forth in the original Contract and the First Extension, except for those specifically modified below.

In accordance with ¶ 19 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. The tables found in Paragraph 1 of the Contract and Paragraph 1 of the First Extension are deleted in their entirety and replaced with the table below. All other text of Paragraph 1 of the Contract and Paragraph 1 of the First Extension remains unchanged.

2. Paragraph 8 of the Contract is deleted in its entirety and replaced with the following:

"Contractor understands and agrees that financial responsibility for claims or damages to any person, or to Contractor's employees and agents, shall rest with the Contractor. Contractor and its subcontractors shall effect and maintain any insurance coverage, including, but not limited to, Workers' Compensation, Employers' Liability, General Liability, Contractual Liability, Automobile Liability and Umbrella Liability to support such financial obligations. The indemnification obligation, however, shall not be reduced in any way by existence or nonexistence, limitation, amount or type of damages, compensation, or benefits payable under Workers' Compensation laws or other insurance provisions.

The minimum limits of insurance required of the Contractor by MPS shall be:

The Milwaukee Board of School Directors shall be named as an additional insured under Contractor's and subcontractors' general liability insurance and umbrella liability insurance. Evidence of all required insurances of Contractor shall be submitted electronically to MPS via its third party vendor, EXIGIS Risk Management Services. Waivers and exceptions to the above limits will be in the sole discretion of MPS and shall be recorded in the EXIGIS system, which records are incorporated into this Contract by reference. The certificate of insurance or policies of insurance evidencing all coverages shall include a statement that MPS shall be afforded a thirty (30) day written notice of cancellation, non-renewal or material change by any of Contractor's insurers providing the coverages required by MPS for the duration of this Contract."
