FIRST EXTENSION & MODIFICATION

On June 1, 2016, the Milwaukee Board of School Directors ("MPS" or "Board") and Durham School Services, LP ("Contractor") entered into Professional Services Contract number B0001195 ("Contract") with a term of July 1, 2016 through June 30, 2017. The Contract, (¶ 2), provided for two additional one-year extensions upon mutual written consent of the parties. The parties now mutually agree to extend the Contract for the first additional one-year term.

As such, the Contract will be extended for a second term from July 1, 2017 through June 30, 2018 under the same terms and conditions as set forth in the Contract, except as specifically set forth below.

The amount to be encumbered on the Contract shall not exceed \$100,000 in Year 2.

In accordance with ¶ 20 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

1. The Specifications to which Contractor is held are updated to the version attached hereto ("GENERAL SPECIFICATIONS AND OPERATING PROCEDURES FOR SCHOOL BUS CONTRACTORS, Effective July 1, 2017") as Exhibit A and incorporated by reference.
2. Paragraph 3 is modified to include the following provisions:
 - a. "Destination rates submitted under RFB 5735 are increased at a rate of 4% for Year 2."
 - b. "Total compensation under this Contract for the term from July 1, 2017 through June 30, 2018 shall not exceed \$100,000 is added."
