Evaluators will be responsible for preparing a research request to the MPS Office of Research and Development, devising data collection systems across agencies and schools when needed, collecting data to monitor program activities and assess outcomes (both secondary and primary), and preparing additional reports. An evaluation team member will attend all regular meetings of the project's Advisory Committee or other project meetings, to remain informed of changes in program activities and provide ongoing results. The evaluation team will prepare and submit evaluation reports as required by the Advisory Committee and/or Project Manager, likely twice each year, and will prepare annual preliminary reports, as well as a final report at the end of the project.

The original contract provided for two one-year options to extend. This will be the second extension of this contract.

This contract extension will run from October 1, 2017 through September 30, 2018. The total cost of the contract in this extension year will not exceed \$75,000.

# Authorization to Extend Five Contracts and Enter Two Contracts with Contractors Providing Services Related to the United States Department of Education's GEAR UP Grant

The Administration is requesting authorization to extend five contracts and enter two contracts to continue implementation of the United States Department of Education's GEAR UP Grant. Extensions are requested with: Board of Regents of the University of Wisconsin System on behalf of UWM – TRIO; Board of Regents of the University of Wisconsin System on behalf of UWM – SREED; Board of Regents of the University of Wisconsin System on behalf of the University of Wisconsin - Madison (PEOPLE); Boys & Girls Club of Greater Milwaukee, Inc.; and Marquette University. New contracts are requested with Cardinal Stritch University and Milwaukee Area Technical College.

In 2011, MPS was awarded a seven-year, \$14.87M federal TEAM GEAR UP Grant to promote college awareness and readiness among middle through high school students. The grant is a partnership model, meaning MPS TEAM GEAR UP works collaboratively with college and community partners to meet programming objectives. The grant serves over 4,000 students in the classes of 2017 and 2018 who are currently enrolled at 8 participating MPS high schools. The 2017-18 school year will be the seventh and final year of the GEAR UP Grant.

By contracting with the aforementioned organizations, the District is able to: increase educational expectations for participating students; increase academic performance and high school graduation rates; promote student and family awareness of postsecondary education options, preparation and financing; and increase post-secondary readiness and enrollment.

Each contract term will run from October 1, 2017 through September 30, 2018. The total cost of the contracts will not exceed \$926,770.56. The table below summarizes each contract term and associated dollar value.

Contractor provided such reports; therefore, MPS is exercising the first option year for the contract.

This contract extension will run from July 1, 2017 through June 30, 2018. The total cost of the contract in this extension year will not exceed \$90,000.
