MILWAUKEE BOARD OF SCHOOL DIRECTORS PROFESSIONAL SERVICES CONTRACT SECOND EXTENSION & MODIFICATION

On July 1, 2014, the Milwaukee Board of School Directors ("MPS" or "Board") and Johnson School Bus Service, Inc. ("Contractor") entered into Busing Contract number C021119 ("Contract") with a term of July 1, 2014 through June 30, 2015. The Contract, (¶ 2), provided for two additional one-year extensions subject to Board approval and contingent on the appropriation of Board funds. The parties mutually agreed to extend the Contract for the first one-year extension period and executed an Extension & Modification ("the First Extension") to that effect in July 2015. The parties now mutually agree to extend the Contract for the second and final additional one-year term.

As such, the Contract will be extended for a final term from July 1, 2016 through June 30, 2017 under the same terms and conditions as set forth in the Contract and any modifications thereof, except as specifically set forth below.

The amount to be encumbered on the Contract shall not exceed \$1,001,000.00 in Year 3.

In accordance with ¶ 19 of the Contract, the parties modify those terms and conditions identified below.

MODIFIED TERMS:

- 1. Paragraph 3 of the Contract and paragraph 2 of the First Extension are modified as follows:
 - a. The table found therein is replace with the table below:

- b. The amount to be encumbered for this additional one-year period shall not exceed \$1,001,000.00; the initial payment, which may be made ten days before services begin, will be \$100,100.00.
- 2. Paragraph 6 of the Contract is deleted in its entirety and replaced with the following:

"In the performance of work under this Contract, Contractor shall not discriminate in any way against any employee or applicant for employment on the basis of a person's sex, race, age, religion, national origin, ancestry, creed, pregnancy, martial or parental status, sexual orientation, disability, or socio-economic status. This prohibition includes but is not limited to employment; promotions, demotions and transfers; recruitment; advertising; layoff or termination; rates of pay or other forms of compensation; and selection for training, including apprenticeships. Contractor is required to include a similar provision in all subcontracts to this Contract.

If MPS determines Contractor has violated this non-discrimination policy, MPS may terminate this Contract without liability for undelivered services or materials. MPS may also deem the Contractor ineligible to participate in future contracts with MPS."
